Matthew Rickman focuses his practice in the areas of white-collar criminal defense and civil litigation.

Matt has successfully represented numerous clients at all levels of both state and federal court proceedings, from the initial stages of an investigation through trial. Drawing upon his experience as a former state prosecutor, Matt has defended individuals in Massachusetts district and superior courts on a wide range of criminal charges, including manslaughter, narcotics-related offenses, domestic abuse, major sexual offenses and rape allegations, felony motor vehicle offenses, civil rights violations, and numerous violent felonies. In federal court, Matt has represented individual professionals and corporate executives throughout criminal investigations and cases alleging health care fraud, public corruption, obstruction of justice, computer fraud, copyright infringement, and identification fraud. He has also handled multiple appellate matters before the Massachusetts Supreme Judicial Court, the Massachusetts Court of Appeals, as well as the Court of Appeals for the First Circuit.

Matt has advised college and university students in the greater Boston area with respect to disciplinary proceedings arising out of alleged conduct violations, including undergraduate and graduate students from Harvard University, Boston University, Boston University, Boston University, Boston University, and M.I.T. Often, Matt's representation of these students includes parallel disciplinary and criminal proceedings. Matt has also represented numerous victims in cases involving domestic abuse as well as stalking and harassment crimes, from the initial stages of an investigation and court hearings, through disposition of the underlying criminal matter.

- Successfully represented a Harvard Law School student in a complex Title IX disciplinary proceeding initiated by a fellow student, resulting in a Not Responsible finding for the client.

 Massachusetts Supreme Judicial Court, on an issue of first impression regarding corporate criminal liability, and then later, before a jury, which returned a
 verdict of not guilty.
